- Global Law and Transnational Legal Studies (from the 2<sup>nd</sup> year);
- Scienze amministrative e giuridiche delle organizzazioni pubbliche e private;

### **Number of participants**

No more than **four** students shall be selected for the European Law Moot Court Competition; no more than **four** for the Telders International Law Moot Court Competition; no more than **six** for the Willem C. Vis International Commercial Arbitration Moot.

### **How to apply**

Applications must be submitted by **10/05/2024 at 12:00**, exclusively through the following **link**. Late applications will not be considered.

Applicants shall list the three competitions offered by the University of Turin (European Law Moot Court Competition; Telders International Law Moot Court Competition; Willem C. Vis International Commercial Arbitration Moot) in **order of preference**. Preferences will be taken into account in drafting the ranking list.

Applicants shall attach:

1. a motivation letter;
2. a cv;
3. the transcripts declaration (“autocertificazione iscrizione e immatricolazione con esami”) downloadable from the MyUnito student profile;
4. copy of ID or passport.

All documents shall be in **PDF** format.

**CV and motivation letter shall be drafted in the language of the competition:**

- English for the Telders International Law Moot Court Competition and the Willem C. Vis International Commercial Arbitration Moot;
- either English or French for the European Law Moot Court Competition.

### **Selection procedure and criteria**

The selection is based on the documents uploaded by the applicants and on an individual interview.

Interviews will take place **in the Meeting Room of the Law Department** on **23/05/2024, starting from 9:00**. The interview will be conducted in English and/or French, depending on the competition(s) chosen.

Requests for online interviews must be made in the application form and will be granted only in exceptional and duly motivated cases.

The interview may include a short written exercise aimed to assess language proficiency and verbal reasoning skills.

After completing the interviews, the selection committee shall establish a ranking list based on the following criteria:

- proficiency in the language of the competition (written and oral) (up to 10/30);
- cv and weighted average of exams (up to 10/30);
- verbal reasoning and synthesis skills (up to 5/30);
- motivation and previous knowledge on the subject(s) the competition relates to (up to 5/30).

Only applicants achieving a score of at least **22/30** will be included in the ranking list.

In case of parity, the applicant having obtained the higher number of credits (CFU) shall prevail.

### **Acceptance**

Within 5 days from the publication of the results, selected students shall communicate their acceptance to [international.cle@unito.it](mailto:international.cle@unito.it).

### **Obligations of selected students**

Successful applicants will form the teams competing for the University of Turin in the three moot court competitions for the 2024/2025 academic year. They undertake to participate in the relevant competition for its entire

duration and with the utmost commitment.

They will be required, in particular, to draft written memoranda and, depending on the rules of each competition, to take part in the oral phase of the competition.

### **Participation in the oral phase**

For each competition, **participation in any phase following the submission on the first memorandum is conditional upon an evaluation of performance** based on commitment shown and results achieved during the previous phase(s).

### **Scholarships**

Only in the case the oral phase of the competition is held in person abroad, students participating in the oral phase will be awarded a scholarship, the amount of which shall be determined by the Department Council.

### **ECTS credits**

Participation in the **entire competition** (written and oral phase) is rewarded with **9 ECTS credits**: 6 credits from the International Moot Courts course (Prof. Alberto Oddenino) + 3 credits as seminar.
